Julian Assange appeared in October at his UK extradition hearing as an example to any journalist against defying the machine. After an extended period in solitary confinement and deteriorating health he was visibly haggard, struggling to remember his own name and birthday.

Worse still awaits him in the United States.

He will be sentenced to life in prison for espionage charges against the war criminals who'scrimes he reported on, and computer intrusion charges for whoever "hacked" the Hillary Clinton emails, which he then published.

Given historic protections extended to journalists from the ire of big government during for instance the Watergate scandal or the publishing of the Vietnam pentagon papers, the illigitamacy of these charges are so transparentthe precedent hardly warrants elaboration. These actions are not to enforce any law or administer justice, instead they serve to publicly demonstrate the de facto rule that exposing government crime is a crime, and no law concerning cruel and unusual punishment applies.





Investigation: The F.B.I. had contact with the Finders since 1971 including a recent report dealing with C.I.A. involvement with at least one of the members of the Finders passing information overseas concerning activities of the Central Intelligence Agency. When it became apparent that no Federal Laws were violated the F.B.I. vacated the investigation.
